<b>TITLE</b> <b>ACORD 93 (2012/03)</b>	<b>Young Driver Questionnaire</b>	The title of the form. ACORD 93, Young Driver Questionnaire, is generally completed by drivers under the age of twenty five. The Young Driver Questionnaire provides additional underwriting information that is usually common to youthful drivers. This form should be completed and signed exclusively by the young driver with no input from the parents and/or agent. The top section of the form must be completed by the young driver in his/her own handwriting.  IMPORTANT: Question # 8 may not be asked in the District of Columbia, Missouri or Ohio.
<b>IDENTIFICATION SECTION</b>	<b>Agency Customer ID</b>	Enter identifier: The customer's identification number assigned by the producer (e.g. agency or brokerage).
<b>IDENTIFICATION SECTION</b>	<b>Driver #</b>	Enter number: The number assigned to the driver by the producer.
<b>IDENTIFICATION SECTION</b>	<b>Date (MM/DD/YYYY)</b>	Enter date: The date on which the form is completed.
<b>IDENTIFICATION SECTION</b>	<b>Agency</b>	Enter text: The full name of the producer/agency.
<b>IDENTIFICATION SECTION</b>	<b>Policy Number</b>	Enter identifier: The identifier assigned by the insurer to the policy, or submission, being referenced exactly as it appears on the policy, including prefix and suffix symbols. If required for self-insurance, the self-insured license or contract number.
<b>IDENTIFICATION SECTION</b>	<b>Effective Date</b>	Enter date: The effective date of the policy. The date that the terms and conditions of the policy commence.
<b>IDENTIFICATION SECTION</b>	<b>Carrier</b>	Enter text: The insurer's full legal company name(s) as found in the file copy of the policy. Use the actual name of the company within the group to which the policy has been issued. This is not the insurer's group name or trade name.
<b>IDENTIFICATION SECTION</b>	<b>NAIC Code</b>	Enter code: The identification code assigned to the insurer by the NAIC.
<b>IDENTIFICATION SECTION</b>	<b>Named Insured(s)</b>	Enter text: The named insured(s) as it/they will appear on the policy declarations page.
<b>QUESTIONNAIRE QUESTIONS</b>	<b>Do you have any driving limitations imposed by your parents?</b>	Enter Y for a "Yes" response. Input N for "No" response. Indicates the response to the question, "Do you have any driving limitations imposed by your parents?".
<b>QUESTIONNAIRE QUESTIONS</b>	<b>Explanation</b>	Enter text: An explanation as to whether the young driver has ever had any driving limitation imposed by parents.
<b>QUESTIONNAIRE QUESTIONS</b>	<b>Do you allow others to use your car? (who and why)</b>	Enter Y for a "Yes" response. Input N for "No" response. Indicates the response to the question, "Do you allow others to use your car?".

QUESTIONNAIRE QUESTIONS	Explanation	Enter text: An explanation as to whether the young driver allows other to use his or her car.
QUESTIONNAIRE QUESTIONS	Has your driver's license or permit been revoked or suspended during the last three (3) years?	Enter Y for a "Yes" response. Input N for "No" response. Indicates the response to the question, "Has your driver's license or permit been revoked or suspended in the last mandated number of years?".
QUESTIONNAIRE QUESTIONS	Suspension Period - Start Date:	Enter date: The date the driver's license suspension became effective.
QUESTIONNAIRE QUESTIONS	Suspension Period - End Date:	Enter date: The date the driver's license suspension is scheduled to end.
QUESTIONNAIRE QUESTIONS	Explanation	Enter text: An explanation as to whether the young driver has had his/her driver's license or permit revoked or suspended during the last three (3) years.
QUESTIONNAIRE QUESTIONS	Reinstatement Date	Enter date: The date a suspended or revoked driver's license was reinstated.
QUESTIONNAIRE QUESTIONS	Have you received any traffic violation*/conviction other than parking? (*Not applicable in Oregon)	Enter Y for a "Yes" response. Input N for "No" response. Indicates the response to the question, "Have you received any traffic violation*/conviction other than parking?" (*Not applicable in Oregon).
QUESTIONNAIRE QUESTIONS	Date	Enter date: The date the driver received the traffic violation.
QUESTIONNAIRE QUESTIONS	Explanation	Enter text: An explanation as to whether the young driver has received any traffic violation*/conviction other than parking? (*Not applicable in Oregon)
QUESTIONNAIRE QUESTIONS	Have you had any accidents as a driver? (During the last three (3) years in Oregon)	Enter Y for a "Yes" response. Input N for "No" response. Indicates the response to the question, "Have you had any accidents as a driver?" (During the last three (3) years in Oregon)
QUESTIONNAIRE QUESTIONS	Date	Enter date: The date of the accident.
QUESTIONNAIRE QUESTIONS	Explanation	Enter text: An explanation as to whether the young driver has had any accidents as a driver.
QUESTIONNAIRE QUESTIONS	Have you ever been arrested or detained for any reason, other than a traffic violation? (Not applicable in Oregon)	Enter Y for a "Yes" response. Input N for "No" response. Indicates the response to the question, "Have you ever been arrested or detained for any reason, other than a traffic violation?".
QUESTIONNAIRE QUESTIONS	Date	Enter date: The date the driver was arrested or detained for any reason other than a traffic violation.

<b>QUESTIONNAIRE QUESTIONS</b>	<b>Explanation</b>	Enter text: An explanation as to whether the young driver has ever been arrested or detained for any reason other than a traffic violation.
<b>QUESTIONNAIRE QUESTIONS</b>	<b>Is the auto you operated modified or equipped with any special equipment, have modified bodywork, or special paint?</b>	Enter Y for a "Yes" response. Input N for "No" response. Indicates the response to the question, "Is the auto you operate modified or equipped with any special equipment, have modified bodywork, or special paint?".
<b>QUESTIONNAIRE QUESTIONS</b>	<b>Explanation</b>	Enter text: An explanation as to whether the young driver operates an auto that is modified or equipped with any special equipment, bodywork or special paint.
<b>QUESTIONNAIRE QUESTIONS</b>	<b>Any auto insurance declined, cancelled or non-renewed during the last three (3) years?</b>	Enter Y for a "Yes" response. Input N for "No" response. Indicates the response to the question, "Have you ever had auto insurance declined or cancelled? (Not applicable in the District of Columbia, Missouri, or Ohio)".
<b>QUESTIONNAIRE QUESTIONS</b>	<b>Explanation</b>	Enter text: An explanation as to whether the young driver has had any auto insurance declined, cancelled or non-renewed during the last three (3) years?
<b>IDENTIFICATION SECTION</b>	<b>Agency Customer ID</b>	Enter identifier: The customer's identification number assigned by the producer (e.g. agency or brokerage).
<b>IDENTIFICATION SECTION</b>	<b>Driver #</b>	Enter number: The number assigned to the driver by the producer.
<b>REMARKS</b>	<b>Remarks</b>	Enter text: The producer's comments.
<b>SIGNATURE</b>	<b>Young Driver's Signature</b>	Sign here: Accommodates the signature of the driver.
<b>SIGNATURE</b>	<b>Date</b>	Enter date: The date the driver signed the form.
<b>SIGNATURE</b>	<b>Producer's Signature</b>	Sign here: Accommodates the signature of the authorized representative (e.g. producer, agent, broker, etc.) by all companies to issue Certificates. This is required in most states.
<b>SIGNATURE</b>	<b>National Producer Number</b>	Enter identifier: The National Producer Number (NPN) as defined in the National Insurance Producer Registry (NIPR). Note: The NPN is not the same as the producer state license number.
<b>Edition</b>	<b>Date</b>	The edition identifier of the form including the form number and edition (the date is typically formatted YYYY/MM).
