

## ACORD 68 TX (2016/03) - TEXAS HOMEOWNERS AND PERSONAL PROPERTY SUPPLEMENT

ACORD 68 TX, Texas Homeowners and Personal Property Supplement, Consumer Bill of Rights, Homeowners, Dwelling and Renters Insurance, complies with Texas laws and regulations which require that every applicant for personal property insurance must be given a copy of the "Consumer Bill of Rights" adopted by the Texas Department of Insurance. ACORD 68 TX contains Spanish language text of the Texas Consumer Bill of Rights.

This form provides information with respect to:

- \* The insured's right to call the Texas Department of Insurance and the insurer with questions or complaints
- \* Discounts and other options available
- \* Restrictions on the insurer's right to deny coverage
- \* Restrictions on the insurer's right to cancel coverage
- \* Claims processing and settlement

Use this form with all ACORD personal property applications, when the Spanish language text is required.

IDENTIFICATION SECTION	Agency Customer ID	Enter identifier: The customer's identification number assigned by the producer (e.g., agency or brokerage).
IDENTIFICATION SECTION	Agency	Enter text: The full name of the producer / agency.
IDENTIFICATION SECTION	Policy Number	Enter identifier: The identifier assigned by the insurer to the policy, or submission, being referenced exactly as it appears on the policy, including prefix and suffix symbols. If required for self-insurance, the self-insured license or contract number.
IDENTIFICATION SECTION	Effective Date	Enter date: The effective date of the policy. The date that the terms and conditions of the policy commence. (MM/DD/YYYY)
IDENTIFICATION SECTION	Named Insured(s)	Enter text: The named insured(s) as it / they will appear on the policy declarations page.
IDENTIFICATION SECTION	Carrier	Enter text: The insurer's full legal company name(s) as found in the file copy of the policy. Use the actual name of the company within the group to which the policy has been issued. This is not the insurer's group name or trade name.
IDENTIFICATION SECTION	NAIC Code	Enter code: The identification code assigned to the insurer by the National Association of Insurance Commissioners (NAIC).
